Message frequency will vary depending on your services, needs, and interaction with Skill Creations, Inc., but will not exceed 5–9 messages per day unless triggered by a notification event.

You may opt out of SMS communications at any time by replying STOP to any message. After opting out, you will receive a confirmation message and you will no longer receive SMS communications unless you opt in again.
